She has many years of teaching experience at Northern Arizona and at the University of Rhode Island. She holds a bachelor's degree from Middlebury College and a master's and Ph.D. from the University of Chicago, all in anthropology. She has completed many years of fieldwork outside of the United States, and appreciates CSUMB's emphasis on global perspective, diversity and multiculturalism.

#### Roe v. Wade Anniversary

Reproductive rights supporters and opponents marked the 35th anniversary of the U.S. Supreme Court's landmark Roe v. Wade decision with marches and rallies, both in Washington D.C. and across the nation. A CNN /Opinion Research survey shows that public opinion on abortion has remained almost unchanged in the past 15 years, with 36 percent of Americans thinking abortion should be legal in all or most circumstances, 40 percent believing it should be available in a few circumstances, such as the health of the mother, and 22 percent believing abortion should never be legal.

AAUW supports the right of every woman to safe, accessible, affordable, and comprehensive family planning and reproductive health services and trusts that every woman has the ability to make her own informed choices regarding her reproductive life within the dictates of her own moral and religious beliefs. Further, AAUW believes that these deeply personal decisions should be made without governmental interference.

"Tres Mujeres: The Three Women" is the current special exhibit at the **National Steinbeck Center**. Deborah Silguero, curator at the Steinbeck Center, has graciously agreed to give our group a guided tour of this exhibition which recognizes the creativity of women artists in the 21<sup>st</sup> Century.

The exhibit features the works of three local artists—Michelle Sarabia, Rebecka Ramirez and Norma Lopez Molina—whose works in ceramics, photography and painting represent subjects of solitude, existence and the meaning of being present. Filipina artist Sarabia focuses on mixed media drawings and glazed ceramics; Latina artist Ramirez creates ceramic works; and Puerto Rican artist Lopez Molina works with photography.

#### **New Perspectives on Tortilla Flat!**

Monterey Librarian-Archivist Dennis Copeland provided fascinating information at January's monthly program on John Steinbeck's *Tortilla Flat.* Focusing on Monterey schoolteacher and poetess Susan Gregory to whom the author dedicated his book, Copeland added much to our understanding of how the author learned about the real Monterey lives he wrote about.

While Ms. Gregory received awards for her teaching and plaudits for her poetry during her life (she died in the 1950s), she has been largely lost to public appreciation. However, after learning all that we did from Copeland, many present suggested that AAUW-MPB participate in efforts to acknowledge Susan Gregory's contributions with a plaque!

Demonstrating public interest in AAUW programs were several non-members, including a visiting tourist from Ireland, who attended after reading public notices. Also present were folks who met at our program after talking by phone about a rescue dog, when the dog's guardian told the callers that she couldn't meet about the dog because she planned to attend the AAUW program!

## A Portrayal of Emily Fish, the Socialite Point Pinos Lighthouse Keeper, by Eleanor Wylde Morrice.

Emily Fish served as keeper of the Point Pinos Lighthouse for 21 years, from 1893 to 1921. She was on duty during the 1906 Earthquake and during the subsequent repairs required from the damage inflicted during the quake. Her hospitality earned her the nickname, "the socialite lightkeeper." Eleanor Wylde Morrice, who is a docent at the Point Pinos Lighthouse, will present a portrayal of Emily Fish for us. Eleanor is well known for community involvement, serving as a volunteer in many heritage organizations and as a singer, dancer and actress. She has portrayed several historical figures associated with the Lighthouses, as well as other wonderful women who have enriched local society.
